# Lac La Biche County Report to Council

SUBJECT: Funding Request - Northeast Mayors, Reeves and Indigenous Leaders Caucus

# COUNCIL MEETING DATE: February 7, 2023

**Purpose:** To seek Council's endorsement to financially contribute to the Northeast Mayors, Reeves and Indigenous Leaders Caucus.

## **Proposed Motion:**

That Council endorse the 2023 Northeast Mayors, Reeves and Indigenous Leaders funding formula request, with a maximum contribution of \$2,000 from Lac La Biche County.

## **Options:**

- Council may approve the proposed funding formula.
- Council may approve funding in a higher or lesser amount.
- Council may request additional information, or await the expected framework for the Caucus, prior to approving funding.
- Council may request additional information on the proposed lobbying efforts prior to providing funding
- Council may decline the funding request.
- Council may decide to not participate in the Caucus.

## **Recommendation:**

Administration supports to proposed motion.

## **Background:**

The Northeast Mayors, Reeves and Indigenous Leaders Caucus is a group of approximately 40 communities, including municipalities (urban and rural), Metis Settlements and First Nations, coming together to represent the collective interests on a regional level. The Caucus has held meetings in Two Hills (April 2022), Lamont (July 2022), Lac La Biche (October 2022) and Cold Lake/MD of Bonnyville (2023). A meeting in mid-March is expected to be held in Vegreville.

Topics considered by the Caucus have included healthcare and doctor recruitment/retention, community safety/policing, municipal funding, broadband and highways (namely Highways 28). Most recently, a group of five representatives have been selected to form a steering committee to review a



funding formal for the Caucus and to hire a lobbyist to further the regional issues with other levels of government.

The Steering Committee has also been tasked with preparing a framework for the Caucus.

Minutes and correspondence from recent meetings indicate a request has been made to fund the lobbying efforts and provide startup dollars for the Caucus. There has been communication about a flat rate (varying by jurisdiction, but \$2,000 for Counties) or population based (\$0.25/capita – 7,673 for Lac La Biche County). Although clarity on the formula will be provided, the request of the County would not be more than \$2,000 at this time.

Mayor Reutov (and Deputy Mayor Pare, in the Mayor's absence) has attending these regional meetings and may provide additional information respecting the request.

#### **Strategic Alignment:**

Recent discussions held by the Caucus align well with Council's overall strategic plan.

#### **Financial Implications:**

**Costs:** \$2,000 **Source of funding:** General Municipal budget

#### **Relevant Legislation, Policy or Practices:**

Lac La Biche County holds membership and pays fees, for other similar organizations. These include the Rural Municipalities of Alberta (and associated District) and Alberta Municipalities.

**Communication:** Administration will liaise with the Town of Vegreville to submit the County's portion of the funding request.
